



## Referral Program Agreement

This “Agreement” (these referral terms together with the documents referred to in it) sets out the terms which govern our referral program (“Referral Program”). Please read this Agreement carefully before you use our Referral Program. By using our Referral Program, you confirm that you accept this Agreement and that you agree to comply with it. If you do not agree to the terms of this Agreement, you must not use our Referral Program.

### 1. REFERRALS

1.1. Subject to your compliance with the terms of this Agreement, UENI shall pay you a referral fee (“Referral Fee”) if you meet the Referral Program requirements (as in force at that time) for your program.

1.2. You may use the Referral Program by sharing a unique link provided by UENI.

1.3. Provided you meet the requirements (as in force at that time), you are entitled to a Referral Fee each time you meet such requirements.

1.4. You must be a registered user of UENI, with an active account, to use the Referral Program.

### 2. PAYMENT

Both you and each friend that signs up to UENI through your unique Referral Program link will be entitled to a \$/£5 cash bonus, payable within 60 days from the moment your friend’s account becomes eligible for the Referral Program.

### 3. PROHIBITED USES

3.1. You may only use our Referral Program in good faith for lawful purposes. You may not:

- (a) create more than one account in order to invite yourself;
- (b) invite others that have created duplicate accounts;
- (c) use alternative contact information to refer yourself or others that have created duplicate accounts;
- (d) invite an existing customer of UENI;
- (e) invite fictitious persons;

(f) do anything that damages UENI's brand, goodwill or reputation;

(g) use the Referral Program in: (i) any way that breaches any applicable local, national or international law or regulation; or (ii) any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect; (iii) in any way that contravenes any other agreements we have with you, including our Terms & Conditions;

(h) to transmit any unsolicited or unauthorised advertising or promotional material or any other form of similar solicitation (spam); or

(i) to transmit any unsolicited or unauthorised advertising either via paid search or any other similar activity, including channels that can damage the UENI brand, goodwill or reputation.

3.2. Any obligation on you not to do something includes an obligation not to allow that thing to be done.

#### 4. IDENTIFICATION DOCUMENTS

4.1. UENI may require identification documents from you prior to paying the Referral Fee.

4.2. UENI shall not be in breach of this Agreement (nor have any obligation to pay you a Referral Fee) if you do not (in UENI's sole and absolute discretion) provide the identification documents requested by UENI.

#### 5. ABUSE OF THE REFERRAL TERMS

5.1. UENI has the right to refuse to pay you the Referral Fee (in its sole and absolute discretion) if UENI suspects that you have not used the Referral Program in good faith or have breached this Agreement.

5.2. We will determine, in our sole and absolute discretion, whether there has been a breach of this Agreement. When a breach of this Agreement has occurred, UENI may take such action as we deem appropriate, including (but not limited to) termination of this Agreement, closing your account(s), closing third party account(s) and suspending the Referral Program.

#### 6. LIMITATION OF LIABILITY

UENI accepts no liability for any use of the Referral Program.

#### 7. CHANGES TO THIS AGREEMENT

We may revise this Agreement at any time by amending this page. Continued use of the Referral Program shall amount to acceptance of the Agreement in force at that time.

#### 8. CHANGES TO THE REFERRAL PROGRAM

UENI reserves the right to:

(a) amend, alter or change the Referral Program at any time, without notice; and

(b) terminate the Referral Program at any time, without notice. In the event the Referral Program is terminated, UENI will not be obliged to credit any accounts that would have otherwise qualified for Referral Fee.

## 9. APPLICABLE LAW

9.1. This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

9.2. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).
